for Annual Shareholders' Meeting

(Summary Translation)

The 2018 Annual General Shareholders' Meeting (the "Meeting") of Silergy Corp. (the "Company") will be convened at 9:00 A.M., Friday, June 8th, 2018 at Four Points (No.631, Zhongzheng Rd., Zhonghe Dist., New Taipei City 23552, Taiwan) .

The agenda of the Meeting is as follows :

1. Report Items :

- (1) To report the business of 2017
- (2) Audit Committee's review report
- (3) To report 2017 employees' and directors' remunerations

2. Recognition and Discussion Items :

- (1) To accept 2017 Business Report and Consolidated Financial Statements
- (2) To accept the proposal for the distribution of 2017 Earnings
- (3) To revise the "Articles of Association"
- (4) To approve the Issuance of New Employee Restricted shares

The major items of the proposal for the distribution of 2017 earnings adopted at the meeting of the Board of Director are as follows :

Cash dividends to common shareholders: Totaling NT\$ 526,395,672. Each common share holder will be entitled to receive a cash dividend of NT\$6.0 per share. (Actual amount of cash dividends distributed in USD to shareholders will be based on the average USD spot foreign exchange closing price of Bank of Taiwan on the record date for the common share dividends.) If the dividend distribution ratio is adjusted due to change of the Company's total number of outstanding common shares it is proposed that the Chairman of Board of Directors is authorized to adjust the ratio of dividend to be distributed to each common share based on the total amount approved by the 2018 Annual General Shareholders' Meeting to be distributed and the number of actual common shares outstanding on the record date for distribution.
