

Application Note: SY8089I

High Efficiency, 1.5MHz, 2A Synchronous Step Down Regulator


General Description

The SY8089I is a high efficiency 1.5MHz synchronous step down DC/DC regulator, which is capable of delivering up to 2A output current. It can operate over a wide input voltage range from 2.5V to 5.5V and integrate main switch and synchronous switch with very low $R_{DS(ON)}$ to minimize the conduction loss.

The SY8089I integrates reliable latch off function when output over voltage, output short or thermal shutdown happens.

The low output voltage ripple, the small external inductor and the capacitor sizes are achieved with 1.5MHz switching frequency.




Figure 1. Schematic Diagram





Figure 2. Efficiency vs. Output Current

Block Diagram




Figure 3. Block Diagram








Startup from Enable $(V_{IN}=5.0V, V_{OUT}=1.8V, R_{LOAD}=0.9\Omega)$




Output Current (A)

Shutdown from Enable











Time (400µs/div)

Load Transient (V_{IN}=5.0V, V_{OUT}=1.8V,I_{OUT}=0.2~2.0A)





Operation

The SY8089I is a high efficiency 1.5MHz synchronous step down DC/DC regulator, which is capable of delivering up to 2A output current. It can operate over a wide input voltage range from 2.5V to 5.5V and integrate main switch and synchronous switch with very low $R_{\rm DS(ON)}$ to minimize the conduction loss.

The SY8089I integrates reliable latch off function when output over voltage, output short or thermal shutdown happens.

The low output voltage ripple, the small external inductor and the capacitor sizes are achieved with 1.5MHz switching frequency.

Short Circuit Protection

After the soft-start is over, if the output voltage falls below 50% of the regulation level, the IC will turn off both power switches, then will enter short circuit protection. It will remain in this state until the IN or EN voltage is recycled.

Over Voltage Protection

If the output voltage exceeds 120% of the regulation level, the IC will turn off both power switches and turn on the discharge switch, then will enter over voltage protection. It will remain in this state until the IN or EN voltage is recycled.

Thermal Shutdown Protection

If the junction temperature of the SY8089I is greater than the thermal shutdown temperature (TSD), the IC will turn off both power switches, and then will enter thermal shutdown protection. It will remain in this state until the IN or EN voltage is recycled.

Applications Information

Because of the high integration in the SY8089I, the application circuit based on this regulator IC is rather simple. Only input capacitor $C_{\rm IN}$, output capacitor $C_{\rm OUT}$, output inductor L and feedback resistors ($R_{\rm H}$ and $R_{\rm L})$ need to be selected for the targeted applications specifications.

Feedback Resistor Dividers RH and RL

Choose $R_{\rm H}$ and $R_{\rm L}$ to program the proper output voltage. To minimize the power consumption under light loads, it is desirable to choose large resistance values for both $R_{\rm H}$ and $R_{\rm L}$. A value of between 10k

and 200k is highly recommended for R_L . If R_L =100k is chosen, then R_H can be calculated to be:

$$R_{H} = \frac{(V_{OUT} - 0.6 \, V) \cdot R_{L}}{0.6 \, V}$$

Input Capacitor CIN

A typical X5R or better grade ceramic capacitor with 6.3V rating and greater than $10\,\mu F$ capacitance is recommended. This ceramic capacitor need to be placed really close to the IN and GND pins to minimize the potential noise problem. Care should be taken to minimize the loop area formed by C_{IN} , and IN/GND pins.

Output Capacitor Cout

The output capacitor is selected to handle the output ripple noise requirements. Both steady state ripple and transient requirements must be taken into consideration when selecting this capacitor. For the best performance, it is recommended to use X5R or better grade ceramic capacitor with 10V rating and greater than $10\,\mu\text{F}$ capacitance.

Output Inductor L

There are several considerations in choosing this inductor.

1) Choose the inductance to provide the desired ripple current. It is suggested to choose the ripple current to be about 40% of the maximum output current. The inductance is calculated as:

$$L = \frac{V_{\rm OUT}(1-V_{\rm OUT}/V_{\rm IN,MAX})}{F_{\rm SW} \times I_{\rm OUT,MAX} \times 40\%}$$

Where F_{SW} is the switching frequency and $I_{OUT,MAX}$ is the maximum load current.

The SY8089I regulator IC is quite tolerant of different ripple current amplitude. Consequently, the final choice of inductance can be slightly off the calculation value without significantly impacting the performance.

2) The saturation current rating of the inductor must be selected to be greater than the peak inductor current under full load conditions.

Isat, min > Iout, max +
$$\frac{V_{OUT}(1-V_{OUT}/V_{IN,MAX})}{2 \cdot F_{SW} \cdot L}$$

3) The DCR of the inductor and the core loss at the switching frequency must be low enough to achieve the desired efficiency requirement. It is desirable to choose an inductor with DCR<30m Ω to achieve a good overall efficiency.



Load Transient Considerations

The SY8089I integrates the compensation components to achieve good stability and fast transient responses. In some application, adding a ceramic capacitor (feed-forward capacitor, $C_{f\!f}$) in parallel with R_H may further speed up the load transient responses and is thus recommended for applications with large load transient step requirements. Typically, for 1.2V/1.8V/3.3V output, the R_H , R_L , $C_{f\!f}$ is recommended as below:

OCP Protection Method

With load current increasing, as soon as the high side FET current gets higher than peak current limit threshold, the high side FET will turn off. If the load current continues to increase, the output voltage will drop. When the output voltage falls below 50% of the regulation level, the output UVP will be detected and the SY8089I will operate in latch off mode.

Layout Design

The layout design of the SY8089I regulator is relatively simple. For the best efficiency and minimum noise problems, we should place the following components close to the IC: $C_{\rm IN}$, L, $R_{\rm H}$ and $R_{\rm L}$.

- It is desirable to maximize the PCB copper area connecting to GND pin to achieve the best thermal and noise performance. If the board space allowed, a ground plane is highly desirable.
- C_{IN} must be close to Pins IN and GND. The loop area formed by C_{IN} and GND must be minimized.
- 3) The PCB copper area associated with LX pin must be minimized to avoid the potential noise problem.
- 4) The components R_H and R_L, and the trace connecting to the FB pin must NOT be adjacent to the LX net on the PCB layout to avoid the noise problem.
- 5) If the system chip interfacing with the EN pin has a high impedance state at shutdown mode and the IN pin is connected directly to a power source such as a Li-ion battery, it is desirable to add a pull down $1M\Omega$ resistor between the EN and GND pins to prevent the noise from falsely turning on the regulator at shutdown mode.





Figure 4. PCB Layout Suggestion



SOT23-5 Package Outline & PCB layout






