Description

SYT01N24AMA is a low-capacitance Transient Voltage Suppressor (TVS) designed to provide electrostatic discharge (ESD) protection for data, control or power lines. With typical capacitance of 12pF only, SYT01N24AMA is designed to protect parasitic-sensitive systems against over-voltage and over-current transient events. It complies with IEC 61000-4-2 (ESD), (±30kV air, ±30kV contact discharge), IEC 61000-4-5 (Surge) (4A, 8/20μs), etc.

SYT01N24AMA uses small SOD-323 package. Each SYT01N24AMA device can protect one automotive Local Interconnect Network (LIN) bus line. It offers system designers flexibility to protect two data lines.



Pin Configuration










Voltage Sweeping of I/O to GND




Capacitance vs. Voltage




Pulse Waveform




Clamping Voltage vs. Peak Pulse Current

ESD Clamping of I/O to GND (-8kV Contact per IEC 61000-4-2)






