

High Efficiency Fast Response, 3A, 40V Input Synchronous Step Down Regulator


General Description

The SY8303A develops a high efficiency synchronous step-down DC/DC converter capable of delivering 3A load current. The SY8303A operates over a wide input voltage range from 4.5V to 40V and integrates main switch and synchronous switch with very low $R_{\rm DS(ON)}$ to minimize the conduction loss.

The SY8303A adopts peak current control scheme. The switching frequency is adjustable from 500 kHz to 2.5MHz using an external resistor. The device also features ultra low quiescent operating to achieve high efficiency under light load. And the internal soft-start limits inrush current during power on.

SY8303A is available in TSOT23-8 package.




Figure 1. Schematic Diagram





Figure 2. Efficiency vs. Load Current































Operation

The SY8303A develops a high efficiency synchronous step-down DC/DC converter capable of delivering 3A load current. The SY8303A operates over a wide input voltage range from 4.5V to 40V and integrates main switch and synchronous switch with very low $R_{\rm DS(ON)}$ to minimize the conduction loss.

The SY8303A adopts peak current control scheme. The switching frequency is adjustable from 500kHz to 2.5MHz using an external resistor. The device also features ultra low quiescent operating to achieve high efficiency under light load. And the internal soft-start limits inrush current during power on.

Applications Information

Because of the high integration in the SY8303A IC, the application circuit based on this regulator is rather simple. Only input capacitor $C_{\rm IN}$, output capacitor $C_{\rm OUT}$, output inductor L and feedback resistors (R_1 and R_2) need to be selected for the targeted applications specifications.

Feedback Resistor Dividers R1 and R2:

Choose R_1 and R_2 to program the proper output voltage. To minimize the power consumption under light loads, it is desirable to choose large resistance values for both R_1 and R_2 . A value of between $10k\Omega$ and $1M\Omega$ is highly recommended for both resistors. If Vout is 3.3V, R_1 =100k is chosen, then using following equation, R_2 can be calculated to be 22.1k:

$$R_2 = \frac{0.6V}{V_{OUT} - 0.6V} R_1.$$

Input Capacitor CIN:

The ripple current through input capacitor is calculated as:

$$\boldsymbol{I}_{_{\text{CIN_RMS}}} = \boldsymbol{I}_{_{\text{OUT}}} \cdot \sqrt{D(1-D)} \cdot \label{eq:cin_rms}$$

To minimize the potential noise problem, place a typical X5R or better grade ceramic capacitor really close to the IN and GND pins. Care should be taken to minimize the loop area formed by C_{IN}, and IN/GND pins. In this case, a 4.7uF low ESR ceramic capacitor is recommended.

Output Capacitor Cout:

The output capacitor is selected to handle the output ripple noise requirements. Both steady state ripple and transient requirements must be taken into consideration when selecting this capacitor. For the best performance, it is recommended to use X5R or better grade ceramic capacitor greater than 22uF capacitance.

Output Inductor L:

There are several considerations in choosing this inductor.

1) Choose the inductance to provide the desired ripple current. It is suggested to choose the ripple current to be about 40% of the maximum output current. The inductance is calculated as:

$$L = \frac{V_{\text{OUT}}(1 - V_{\text{OUT}}/V_{\text{IN,MAX}})}{F_{\text{SW}} \times I_{\text{OUT,MAX}} \times 40\%}$$

where Fsw is the switching frequency and $I_{\text{OUT},\text{MAX}}$ is the maximum load current.

The SY8303A regulator is quite tolerant of different ripple current amplitude. Consequently, the final choice of inductance can be slightly off the calculation value without significantly impacting the performance.


 The saturation current rating of the inductor must be selected to be greater than the peak inductor current under full load conditions.

$$I_{SAT, \, MIN} > I_{OUT, \, MAX} + \frac{V_{OUT}(1\text{-}V_{OUT}/V_{IN, MAX})}{2 \cdot F_{SW} \cdot L}$$

3) The DCR of the inductor and the core loss at the switching frequency must be low enough to achieve the desired efficiency requirement. It is desirable to choose an inductor with DCR<50m Ω to achieve a good overall efficiency.

External Bootstrap Cap

This capacitor provides the gate driver voltage for internal high side MOSEFET. A 100nF low ESR ceramic capacitor connected between BS pin and LX pin is recommended.







Switching Frequency Setting:


Connect a resistor from FS pin to GND to adjust the switching frequency. The switching frequency is adjustable from 500kHz to 2.5MHz. The switching frequency can be calculated by below equation:

$$Fsw(kHz) = \frac{10^5}{R_{ES}}$$

Where R_{FS} is in $k\Omega$.

Load Transient Considerations:

The SY8303A regulator IC integrates the compensation components to achieve good stability and fast transient responses. In some applications, adding a ceramic cap in parallel with R1 may further speed up the load transient response and it is recommended for applications with large load transient step requirements.



Short-Circuit Protection:

SY8303A integrates hic-cup mode short circuit protection function. If the device V_{OUT} drops below 33% of the set-point, the short-circuit protection mode will be initiated. The device will shut down for approximately 4.5ms, then restart with a complete soft-start cycle that is approximately 1.5ms. If the short circuit condition remains another 'hiccup' cycle of shutdown and restart will continue indefinitely.

Over-temperature Protection (OTP)


SY8303A includes over-temperature protection (OTP) circuitry to prevent overheating due to excessive power

dissipation. This will shut down switching operation when the junction temperature exceeds 150° C. Once the junction temperature cools down by approximately 15° C the IC will resume normal operation with a complete soft-start cycle. For continuous operation, provide adequate cooling so that the junction temperature does not exceed the OTP threshold.

Layout Design:


The layout design of SY8303A regulator is relatively simple. For the best efficiency and minimum noise problem, we should place the following components close to the IC: C_{IN}, L, R1 and R2.


- 1) It is desirable to maximize the PCB copper area connecting to GND pin to achieve the best thermal and noise performance. If the board space allowed, a ground plane is highly desirable.
- 2) C_{IN} must be close to Pins IN and GND. The loop area formed by C_{IN} and GND must be minimized.
- 3) The PCB copper area associated with LX pin must be minimized to avoid the potential noise problem.
- 4) The components R_1 and R_2 and the trace connecting to the FB pin must NOT be adjacent to the LX net on the PCB layout to avoid the noise problem.
- 5) If the system chip interfacing with the EN pin has a high impedance state at shutdown mode and the IN pin is connected directly to a power source such as a Li-Ion battery, it is desirable to add a pull down 1Mohm resistor between the EN and GND pins to prevent the noise from falsely turning on the regulator at shutdown mode.







TSOT23-8 Package Outline Drawing









Recommended PCB layout (Reference only)




