SYS03N24AOC is a double lines Transient Voltage Suppressor (TVS) designed to provide electrostatic discharge (ESD) protection for cell phones, notebook computers, PDA's. The SYS03N24AOC is designed to protect sensitive semiconductor components from damage or upset due to electrostatic discharge (ESD)

and other over-current transient events. It complies with IEC 61000-4-2 (ESD)(\pm 30kV air, \pm 30kV contact discharge), IEC 61000-4-4 (electrical fast transient - EFT) (40A, 5/50 ns), IEC 61000-4-5 (Lightning) 8A (8/20 μ s), very fast charged device model (CDM) ESD and cable discharge event (CDE), etc.

SYS03N24AOC is in SOT23 package with working voltage of 24V. SYS03N24AOC can protect two unidirectional lines. It offers system designers flexibility to protect two data lines, and it can be used to meet the ESD immunity requirements of IEC 61000-4-2, Level 4 (\pm 30kV air, \pm 30kV contact discharge). SYS03N24AOC can be used in lots of applications.





Pin Configuration










Voltage Sweeping of I/O to GND




Capacitance vs. Reverse Voltage




Clamping Voltage vs. Peak Pulse Current




8/20µs Pulse Waveform



ESD Clamping of I/O to GND (+8kV Contact per IEC 61000-4-2)




ESD Clamping of I/O to GND (-8kV Contact per IEC 61000-4-2)








